 In Kenya, Teleios Ministry provided material and human resource assistance in support of the education and welfare of orphans and vulnerable children. Also, we sponsored health care initiatives in underserved areas. Further, work was focused on church and related ministry development, including land purchase and building construction to enable ministry growth. Other efforts both capital expenditures and operational projects have partnered with the business community and local community leaders to provide leadership and business entrepreneurial training, support, funding for small business expansion and startup, and the continuing growth of local water systems. Increasing emphasis has been placed on women's business and personal development, as well as training for ministry leaders and their wives. Efforts are made to encourage sustainability and indigenously supported replication.

4b (Code _____) (Expenses \$ 247,468 including grants of \$ _____) (Revenue \$ 41,582)
 In Tanzania, Teleios Ministry provided material and human resource assistance in support of the education and welfare of orphans and vulnerable children. This included primary for the operation of two children's homes and the affiliated programs associated with those institutions. Also, a secondary school is part of this partnership. Work was performed to maintain and improve the physical plants of each operating entity this year. Also, efforts to partner with training and material support were provided in the strategic planning, training, and growth of healthcare and ministry. Alumni of the children's homes continue to be included in the strategic plan for the long-term sustainability of this work. Several receive assistance with education and technical training, and then in turn are becoming vital members of the local support community. The only fundraising event conducted by Teleios Ministry is a golf tournament. Net income was over \$40,000 (related costs of only 15% of revenues). All of the net supported the work of the children's homes.

4c (Code _____) (Expenses \$ 166,861 including grants of \$ _____) (Revenue \$ _____)
 In Romania, Teleios Ministry provided material and human resource assistance to several indigenous ministry projects in the Transylvania area of Romania. Partnerships included work in new church growth, leadership development, economic opportunity, child development, and adult education. Specific efforts targeted women's leadership development, and building competencies toward economic opportunity development for ethnic minorities. Also, construction of a children's home has been completed. Here too, indigenous leaders are moving toward greater self-sustainability, and new work is being initiated locally.
