In December of 2017, the Buncombe County Board of Commissioners approved a resolution to create a new Library Board of Trustees, and the Board was subsequently formed in 2018. The new Library Board worked with the Library Director to research the reactivation of the Library Trust Board. In late 2019, the Buncombe County Attorney's Office reviewed the establishing documents of the Trust Board, and advised that the three principals should meet to review steps for reforming the Trust Board. The principals met and continue working on that process.
