28 -The General Assembly held workshops at its annual meeting in Louisville, KY (October 30th) on 'Best Practices' that are being used in K-12 education programs that help in recruiting students for enrollment in university forestry and natural resources programs. The information that was collected was to be summarized and distributed to the membership by the Education Committee. -NAUFRP co-sponsored the Family Forests Education Award with the National Woodland Owners Association. This award is presented annually at the NAUFRP General Assembly. In 2019 the award was presented to the University of Georgia for their comprehensive education program for family forest landowners. -NAUFRP amended its Articles of Organization (By-Laws) by a vote at the annual General Assembly Meeting on October 30, 2019 in Louisville, KY. Most of the amendments were stylistic/editorial in nature with the exception that the Ad Hoc Communication Committee, established in 2017, became a standing committee. (Grants \$ 47,894)	28a	☐

29 -In 2019, work continued to increase awareness and recognition of the USDA McIntire-Stennis Cooperative Forest Research Program. A major focus was to encourage NAUFRP institutions to use a template developed by the Communications Committee to highlight compelling examples of forestry and natural resources research and resulting impacts through the McIntire-Stennis program. These issue papers are intended to be shared with a wide ranging of audience and posted on the NAUFRP webpage. At least 20 institutions have developed multiple papers. -Because of the federal government shut down in early 2019, plans by NIFA and NAUFRP to host a March conference in Washington DC of university Agriculture Technical Representatives (ATRs) for the NIFA McIntire-Stennis Cooperative Forestry Research Program were canceled. Work on this was underway into early 2019. The conference has not been rescheduled yet because of the federal agency's move to Kansas City, MO. This was to be an opportunity to discuss issues and questions related to the better implementation of the McIntire-Stennis program and is expected to occur at some point in the future. 30 -Executive Committee members contributed to content of NAUFRP webpage and continued focus on strengthening regional organizations and engaging membership. -The NAUFRP Executive and Research Committees are working with the U.S. Endowment for Forestry and Communities to organize a National Research Summit relative to forestry research in the U.S. The goals of the summit are to determine consensus on research challenges (national and regional); develop recommendations for an effective structure to meet those challenges and recommend a coordinated system to review, recognize and update challenges. Participants and Steering Committee Members were in the process of being identified in late 2019 and funding (grant proposals) sought from the USDA Forest Service and National Institute of Food and Agriculture. At the end of 2019, plans were targeting Fall 2020 for the Summit to occur in a central and easily accessible location. -Increasing diversity and inclusion within NAUFRP institutions (faculty and student body) continues to be a priority of the organization. NAUFRP has assisted the Society of American Foresters (SAF) with developing a national Diversity and Inclusion Policy and creating a Diversity and Inclusion Working Group and Diversity Leadership Award. NAUFRP plans to establish a 'clearing house' on academic institutions diversity efforts and actions for the association's webpage. The NAUFRP Diversity Chair participates in the annual meetings of the Minorities in Agriculture, Natural Resources and Related Sciences the 1890 (institutions) Agriculture Research Directors. -The Executive Committee continued to work on integrating data that NAUFRP has collected over a two decade period on students in forestry and natural resources programs with that collected by the USDA Food and Agricultural Education System (http://www.faeis.ahnrit.vt.edu/). -The association continued work on a national Forest Health Initiative in collaboration with the Association of Public Land Grant University. Led by Dean John Hayes (Colorado State University), a steering committee was established and a white paper developed and approved by both organizations outlining the structure and writing teams needed. Work and writing on the various themes continued in 2019. A draft was expected to be reviewed by the Executive Committee in March 2020. -Throughout 2019 NAUFRP worked closely with the Society of American Foresters (SAF) to consider the idea of administering a national Certified Forester (CF) Exam for graduating seniors upon their exit at NAUFRP institutions. Currently this exam is not required and is typically taken later and independently in a forester's career. The proposed change and potential impacts raised numerous questions and concerns and NAUFRP appointed a representative to liaison with SAF. Ultimately a survey was conducted among NAUFRP program administrators and discussions held with the SAF leadership at the NAUFRP October Executive Committee and General Assembly meetings. In December 2019, SAF tabled this proposal. -In summer 2019, NAUFRP re-circulated a 2014 letter that more than 100 forestry and natural resource faculty and administrators had previously signed supporting the use of certain scientific fundamentals in developing a science-based approach to biomass (carbon) energy production. The original purpose of the letter was to inform policy makers and the larger community involved in the use of forest biomass energy which has been and still is, publically debated. Re-circulating the letter was intended to give international colleagues the opportunity to express their support. This letter can be viewed on the NAUFRP webpage. (Grants \$ 23,688)	30a
