Form 990 - Overall Document - This is the first year that Community of Hospitality, Inc. (COH) is filing Form 990 vs. prior year's 990EZ.

Although total annual revenue in 2018 and total assets are still within the threshold for 990EZ, planning by the Board in 2019 and updated assessments of our two properties makes it highly probable that 2020 will necessitate Form 990 filing. Also, per answers to questions in Part V the Board is preparing in 2020 engage internal and external management and accounting professionals to assure highest quality non-profit accounting performance.

Form 990 - Part X line 10a & 10b - In late 2018 COH did its first updated property assessment in over two decades of its 305 Mead Rd Decatur property. The increase was from \$135k+ to \$700k. Also in collaboration with the Community Foundation of Greater Atlanta, assessment of the 458 Edgewood Avenue property was updated to a \$350k value. Those property values had not needed to have been reported in prior Forms 990 EZ. They will need to be reported in the foreseeable future

Likewise, COH equipment secured over 15 years ago for both the 305 Mead Rd property and the 458 Edgewood and connected 460 Edgewood Ave property (owned by the Community Foundation) HAS been tracked in prior 990EZ Schedule O and Form 4562, but preparation for this report finds that recent years' tracking of the value of equipment has been correct in the cumulative value of those items (\$148,631) but that all of those items have fully depreciated - not with a remaining value at the end of 2018 of \$29,278.

Form 4562 - Per the property references above, this year's Form 4562 correctly lists and values the two properties and no longer lists
