THIS CHANGE IN THE BY-LAWS HAS INCREASED OUR DISBURSEMENTS, AND WILL IMPROVE THE RATIO. THE BULK OF OUR DONATIONS COME FROM RETIRED UNITED AIRLINES PILOTS AND FAMILIES, AND ALL OF THE CASH AWARDS GO TO UNITED AIRLINE WIDOWS AND FAMILY MEMBERS WHO QUALIFY ACCORDING TO THE BY-LAWS.
