Tennessee Health Care Campaign (THCC) was incorporated as a 501(c)(3) in 1989 with a vision for all Tennesseans to have affordable, high quality, and equitable health care. Over the course of our 30-year history, we have led advocacy efforts to expand Medicaid to pregnant mothers and children, served as an ombudsman program to help TennCare applicants, and mobilized volunteers to support direct outreach and enrollment of uninsured Tennesseans.

THCC held a conference with speakers with the intent to educate Tennesseans about the impact of health policies on federal and state levels and make health care an issue that stays front and foremost in our policymakers' minds, open the discussion of a national health care plan or more effective Affordable Care Act, and teach people advocacy skills that they can use for health care justice. Participants paid an entrance fee and companies and individuals also sponsored the event.

Educated the public about the provisions of the Affordable Care Act (ACA) by conducting public meetings across Tennessee, training volunteers to make public presentations, and organizing educational events through local organizing groups (LOGs) in Memphis, Jackson, Nashville, Cookeville, Chattanooga, Knoxville, and TriCities areas. In addition, LOGs conducted regional training meetings and assisted the public with registering for health care insurance and/or subsidies in these locations.
