COMMUNITY ENGAGEMENT AND EDUCATION IN 2019, PARK PRIDE PRESENTED OUR 18TH ANNUAL PARKS & GREENSPACE CONFERENCE, "PARKS ARE THE HEART OF COMMUNITY" EXPLORING THE ROLES PARKS PLAY IN MITIGATING THE EFFECTS OF DISRUPTIVE EVENTS SUCH AS FLOODING AS WELL AS MORE GRADUAL CHANGES LIKE POPULATION GROWTH. OVER 500 ATTENDEES GATHERED TO HEAR FROM LEADERS WHO ARE GUIDING THE GREENSPACE CONVERSATION LOCALLY, NATIONALLY AND GLOBALLY.
