These facilities include but are not limited to Audubon Park, the Audubon Zoo, the Aquarium of the Americas, Woldenberg Riverfront Park, the Entergy Giant Screen Theater, the Freeport McMoran Audubon Species Survival Center, the Audubon Louisiana Nature Center, Audubon Wilderness Park and the Audubon Butterfly Garden & Insectarium. The board members for ANIF are selected mainly from board members of Audubon Nature Institute and Audubon Commission. In 2019, the 9 members of the board for ANIF were made up of 5 members from the ANI board and 3 members of the Audubon Commission board. The remaining member was a previous board member of ANI. By-laws of ANIF state that the Chairman of the Audubon Nature Institute board serves as a member of the Foundation board during his/her tenure. The remaining board elects its new members on a rotating basis. In practice the ANIF board has mainly been comprised of current and former ANI and Audubon Commission board members. In regards to officers of the organizations, Ron Forman is the President/CEO for both the Audubon Nature Institute and Audubon Nature Institute Foundation. William Kurtz is the Sr. Executive Vice President/New Revenue Opportunities for Audubon Nature Institute and the Secretary/Treasurer for Audubon Nature Institute Foundation. Through the board representation from ANI and Audubon Commission board members on the ANIF board, the supported organization is able to operate and supervise ANIF. Also, the staffing of ANI and ANIF, which both use Ron Forman and William Kurtz as officers, contributes to the operation and supervision of ANIF by ANI.
