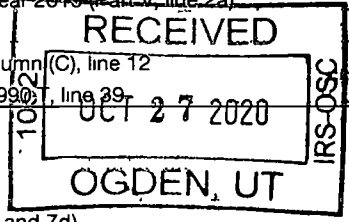

CONSULTING & TRAINING SERVICES AND COLLABORATION: (1) Consulting Services: 2019 was a year of transition for Be Present, Inc. (BPI). Local events were conducted by the Local Organizing Core Groups, and the Be Present office concentrated on building Consulting Services for NPO's. BPI worked with 6 NPO's in 2019: (i) Women's Studies in Religion Certificate, a Program of the Graduate Theological Union Dean's Office in CA -- BPI conducted a workshop entitled, "Weaving Faith into Action for Real!" Approximately 25 graduate students and faculty attended. This workshop was conducted in collaboration with Wisdom & Money, an NPO to which BPI also provides consulting services. (ii) Wisdom & Money, a CA NPO that supports people to explore their relationship with money as a powerful spiritual practice that can lead to inner and outer

National Leadership Development: Be Present, Inc. (BPI) achieved many goals in FY 2019 to futher its commitment to leadership development: (1) Regional Organizing Core Group (ROCG) Support and Development - BPI supported Regional Organizing Core Groups (ROCG'S) in NY, CA and GA to organize in local communities by developing Peer Led Support Groups holding free monthly developer's meetings to train people in the BPDM. Approximately 120 people were served in 2019. It also supported emerging ROCG's in OR, OH, NC and SC in the United States and adults and youth organizing in San Marcos de la Laguna in Guatemala by providing telephone and online technical assistance and training on the BPDM and working extensively with their leadership teams. (2) Children & Youth Leadership Program (CYLP): The CYLP is a partnership between

FISCAL SPONSORSHIP FOR 2 ORGANIZATIONS: BPI was a fiscal sponsor for Atlanta Sisters & Allies, a Regional Organizing Core Group in the BPI network (ATLS&A) and The Destination Design School for Argicultural Estates (DDS). The \$1,500 grant for ATLS&A represented an investment in youth leadership and their significant role in education reform in the South. This initiative ensures that leadership work is not only done "for" youth but also "by" youth - inclusive of youth voices, perspective and leadership. The second organization is DDS. BPI began its fiscal sponsorship in 2018 under a grant for pre-production and shooting a trailer that introduces the documentary project, DIGGING DEBOIS: DESIGNING A DRAWDOWN TRAIL IN GEORGIA. The trailer depicts the process undertaken to design and develop a 300-mile agricultural

(vi.) BPI collaborated with Wisdom & Money to develop leadership training for the Charles River Episcopal Co-Housing Endeavor (CRECHE) in MA. The planned workshop was cancelled because the organization decided to implement a previous training and design that was requested by community members; BPI training was postponed until 2020. (2)

Training Services: BPI designed and hosted a training workshop entitled "Sustaining a Practice of Community Engaged, Transformative Philanthropy", in collaboration with Wisdom & Money in February, 2019. This highly participatory workshop provided an opportunity for participants to experience how the BPEM and Living in the Flow of Gift allow wisdom and compassion to inform interactions around money and wealth. Collaboration: Social justice is not accomplished by one organization working alone, but by partnerships of organizations working together for the social good and for justice. An essential pillar of the BPEM is building strong and sustainable alliances and partnerships. In 2019 BPI and Wisdom & Money worked together on several projects, including the consulting and training services set forth above, as well as co-hosting "Trailblazing Be Present - Wisdom & Money Boards of Directors Meeting" in February 2019 and creating a Trailblazing Team that met monthly throughout 2019 to explore opportunities for partnership, including an 18-month training institute to begin in 2020

S. soccer, basketball, etc.). The trip was originally scheduled for 2020 but has been delayed until 2021 because of COVID-19. (3) National Leadership Network Monthly Convenings. The National Leadership Network team is composed of representatives from each ROCG and the BPI Board of Directors. They convened monthly by telephone or in person to report on activities in each development area; to monitor progress on actualization plans; and

National Leadership Network Annual Convening and Training (NLNT): In November BPI held its annual NLNT. This week began with a 2-day BPI Board Meeting open to the public; followed by a Training Workshop entitled, "Leadership for Social Justice and Equity: Weaving Trust, Collaboration and Play." The workshop teaches how to build diverse, collaborative partnerships for social justice. On the final evening of the event, the Children and Youth Leadership members hosted a "Creativity Evening" in which they shared the BPEM through dance, spoken word and song. The NLNT was attended by approximately 100 people.
