Part VII-A – Question 5 – Termination of Foundation

On November 27, 2019, the Trustees of The Olin B. King Foundation approved a plan to terminate the foundation and transfer all remaining assets to Vanguard Charitable Endowment Program, a public charity that has been in continuous existence for more than 60 months.

Vanguard Charitable was incorporated in the Commonwealth of Pennsylvania and is recognized by the IRS as a tax-exempt public charity under sections 501(c)(3), 509(a)(1), and 170(b)(1)(A)(vi) of the Internal Revenue Code.

On December 23, 2019 the Foundation completed its liquidation by transferring \$2,975,843.65 to Vanguard Charitable Endowment Program.
