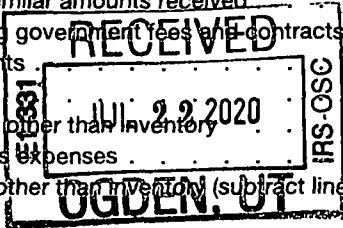



GRANT #1 - In February 2019 the organization was awarded a Grant from the National Endowment for Democracy (NED 2019-0227) for the amount of \$120,258. The purpose of the grant is to continue to support the organization's work promoting greater interaction between pro-democracy, human rights activists and regular citizens that seek solutions for community problems. The grant was awarded as part of a grant between the National Endowment for Democracy and the US Dept of State (Grant Number S-LMAQM-17-GR-1221).

In 2018 we had been awarded a similar grant (NED 2018-0248) running from Feb 1, 2018 to Jan 31, 2019. The total amount received (from both NED grants) during the year 2019 is \$18,796 + \$120,258 = 139,054. The amounts paid (line 10) were \$90,793

GRANT #2 - In June 2017 the organization received a grant from the International Republican Institute (IRI), an award from the United States Agency for International Development, (USAID Award AID-AAA-A-16-0040) for the provision of humanitarian assistance to political prisoners in Cuba and their families. The USAID program is planned for 36 months. In 2019 the organization received \$127,537 and and line 10 amounts paid were \$84,445. This grant is scheduled to end in 2020.

GRANT #1 - For the NED program, a total of 21 Civic Centers were supported with laptop computers, printers, digital phones, and printing supplies, as well as internet access (wi-fi minutes) for reporting and communications. The goal of the program is to assist and empower citizens to assert their civil and human rights by filing cases with local officials regarding instances of neglect, arbitrary home evictions and other human rights issues. During 2019 an average of 28 cases per trimester were presented to local authorities.

In addition some of the Civic Centers also print a 2 page newsletter for dissemination in their respective provinces. Eleven (11) of the 21 Civic Centers printed the newsletter for dissemination in their respective provinces. Details of the activities performed are detailed in quarterly reports (financial and narrative) required by the National Endowment for Democracy.

GRANT #2 - For the USAID program (Humanitarian Assistance to Political Prisoners and their families), a total of 135 families of current or former political prisoners (or other persecuted and marginalized citizens) were assisted in 2019 with delivery of food supplies and over the counter pharmaceuticals and vitamins. The shipments are made as a supplemental aid to the families with each family receiving aid approximately every 2 months. The 135 families represent a total of 570 people receiving the humanitarian aid.

The commodities shipped are from a list approved by USAID following guidelines of the US Dept of Commerce.

A detailed "shipment by shipment" status is detailed in quarterly reports (financial and narrative) required by the grantor (USAID / IRI).
