Gift cards provided for holiday gifts are the only variance to this policy. Volunteers sign an affidavit of receipt for holiday gift cards and provide case information on the family recipient to ensure gift cards are provided only for authentic clients. We have documented procedures and policies and have full internal controls and distribution of duties to provide for controls. Monthly, an external bookkeeper enters information into QuickBooks and reviews receipts and backup documents. The Treasurer then samples all backup and requests monthly after the external bookkeeper completes her role. Financial reports are then reviewed by both the Finance Committee and the Executive Committee on a monthly basis. The Board of Directors reviews all financial reports at each meeting and has an opportunity to ask the Treasurer and Executive Director questions about any trends or variances.
