Action Ministries provided food, paper products and groceries to families 10,778 times during 2019. We helped 2,417 different households and 898 families per month. In addition to food purchased by Action Ministries, food and other household products were donated by businesses, schools and individuals. In addition to the local families served on a monthly basis, Action Ministries provided food and paper products to Food Pantries, Churches, Schools and families in Ohio, Kentucky and Indiana. Over 1,715,904 pounds were distributed in 2019.
