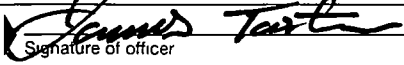

*The corporation raises funds for its exempt purpose by means of an annual raffle, and an auction held at the raffle banquet. Gross ticket sales far exceed the value of the raffle prizes. The purchasers of the raffle tickets understand that fact. Hundreds of persons from the community purchase the tickets as a means of supporting the organization. A banquet is held at which the prizes are drawn. Also at the banquet some items are auctioned. The bids far exceed the value of the items auctioned, as the bidders understand they are supporting the organization, which in turn supports the Search and Rescue unit of Codington County, South Dakota. The net from the raffle sales and net auction sales are included on this line.

SCHEDULE G - 2019

At the raffle banquet there are also prizes auctioned off. About 90% of the prizes go to the raffle, so 90% of the non-cash prizes have been attributed to the raffle and 10% to the raffle banquet. Raffle banquet receipts were 36% of the total, so 64% of the other expenses (including food and beverage) have been attributed to the raffle and 36% to the raffle banquet.
