and our website. Mailings are made to over 4000 eight times a year. An annual "Resource Book" is researched, published and  
and printed for distribution at our annual dinner, and other interested educators, youth directors, church pastors and ministers, and  
other interested parties. The publication itself increase by one third in volume over the prior year. This calendar, supported by  
a donation, we presented outdoor billboards displayed in the city of Pontiac, MI.

Operation of three offices that are open daily to our membership and communities. Offices serve with phone, websites, educational  
printed material, advocacy materials, and at times referrals to public and private agencies in the community. An experienced  
staff can respond to current issues and support our members. The "Main" office houses the "Wee Care" Program that maintains  
a clothes closet for newborns. The Program provides much needed supplies, layettes, and educational material for infants to  
over 600 families every year that are referred to us by state social workers, service agencies, and known individuals. Office space  
Chapter offices also maintain space need to operate our youth activities. This year we hired another youth director for the  
tri-county area that we serve.

The Annual March for Life to Washington D. C. is open to all high school students in the tri-county area. We chartered six (6) busses  
attend each allowing for 50 students, bus captains, chaperones, and often parents. All are volunteers for this project. Costs to  
students is for the transportation and meals. Lodging is provided by local churches of the Washington D. C. area. Though the  
number of busses are less the the prior year, we are proud to advise that several schools have taken on the March for Life Project,  
and are now sponsoring their own journey to the event.
