In partnership with Global Ecovillage Network, Permaculture Institute of North America, and Gaia University, the Institute educates international students and transfers technologies through an immersion pedagogy of ecovillage living, classroom activity and hands-on skill-building exercises, together with workshops, lectures, practical demonstrations, publications, and outreach on six continents. In 2019 GVI provided more than 50 public lectures and 20 extended workshops (including Belize, Canada, Mexico, Ireland, UK, Spain, Estonia, Italy and the US), and produced numerous publications and course materials.
