VMC DENTAL CLINIC PROVIDES COMPREHENSIVE DENTAL CARE AND TREATMENT TO THE HOMELESS AND LOW INCOME OF KNOX COUNTY. ALL SERVICES ARE PROVIDED BY VOLUNTEER DENTAL PROFESSIONALS AT NO COST TO THE PATIENT. IN 2019, THERE WERE 1,463 PATIENT VISITS WITH 2,631 DENTAL PROCEDURES PERFORMED. STREET OUTREACH PROVIDES SOCIAL SERVICE WORKERS TO PERSONS EXPERIENCING HOMELESSNESS ON THE STREETS IN THE KNOXVILLE COMMUNITY. TWO OUTCOMES ARE TRYING TO BE ACHIEVED. THE FIRST IS TO CONNECT INDIVIDUALS AND FAMILIES EXPERIENCING HOMELESSNESS WITH A HOUSING CASE MANAGER TO DEVELOP A HOUSING CASE PLAN AND OTHER SOCIAL SERVICES. THE SECOND IS TO EMPOWER AND ASSIST INDIVIDUALS AND FAMILIES TO ACHIEVE AND SUSTAIN PERMANENT HOUSING. IN 2019, THE PROGRAM ENGAGED 545 INDIVIDUALS. OF THESE INDIVIDUALS, 105 WERE EXITED FROM STREET OUTREACH UPON BECOMING ENGAGED WITH HOUSING CASE MANAGEMENT PROGRAMS. OF THESE 105, 15 HAD ACHIEVED PERMANENT HOUSING BY THE END OF 2019. LOW BARRIER SHELTER AS A COLLABORATIVE EFFORT BETWEEN THE SALVATION ARMY AND VOLUNTEER MINISTRY CENTER, PROPOSED IS THE OPERATION OF A LOW-BARRIER, HOUSING FOCUSED OVERNIGHT EMERGENCY SHELTER FOR 40 INDIVIDUALS EXPERIENCING HOMELESSNESS AND WHO ARE NOT ACCESSING A TRADITIONAL EMERGENCY SHELTER. VOLUNTEER MINISTRY CENTER OPERATES THE SHELTER WHILE UTILIZING A BUILDING ON THE CAMPUS OF THE SALVATION ARMY. THE LOW BARRIER SHELTER OPENED ON DEC 17, 2019.
