THE FOUNDATION PROVIDES FUNDS FOR A VARIETY OF PROGRAMS AND SERVICES WHICH ASSIST COLLEGE STUDENTS IN MEETING THEIR EDUCATIONAL AND PERSONAL DEVELOPMENT OBJECTIVES THROUGH SCHOLARSHIPS, GRANTS AND PROGRAM ASSISTANCE.
