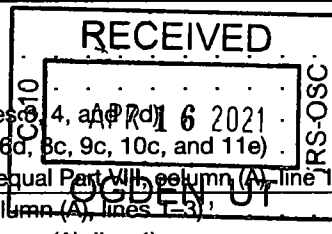

Support Junior Optimist Clubs in 6 schools, teaching students skills in public speaking, the proper way to conduct meetings, and how to handle finances.

The Hawthorne Music Conservatory program provides private and small group music lessons for underprivileged children. Current instruments offered include: Piano, Violin, Guitar, Saxophone, Clarinet, and Percussion. Their philosophy is that any child who desires to learn a music instrument should be able to do so in a loving and uplifting environment, regardless of their financial situation. In addition, they provide dance and ballet classes at their dance and arts studio.

In an ever changing complex world, it is more important than ever that our nation's youth are prepared to bring knowledge and skills to solve problems, make sense of information, and know how to gather and evaluate evidence to make decisions. These are the kinds of skills that students develop in science, technology, engineering, and math disciplines - collectively known as STEM. We made grants totaling \$ 19,942 to 19 STEM programs in Huntsville, Madison, and Madison County Schools. No one program received over \$ 2,000.
