There is no board or governing body for this Foundation. The trust agreement spells out exactly what is required of Regions Bank, the trustee for the Foundation. The following information is an explanation of that process:

1. All of the net income of the trust is distributed three times a year to the institutions of higher learning based on a ratio prescribed in the trust agreement.
2. Each institution administers the trust funds through its student financial aid office under policy set by the scholarship committee of each institution in making educational grants to students in conformity with the trust agreement.
3. Only students from Attala, Carroll, Choctaw, Montgomery & Webster Counties, Mississippi with a desire for a higher education and potential ability to benefit from such education, are eligible for the awards.
4. Each of the institutions make residency determinations based upon Mississippi statutory law, judicial opinions and Attorney General rulings that address residence for tuition purposes at state institutions of higher learning. The committee on residency of each institution reviews the applications of students and uses various methods within the framework of the law to verify the residency and eligibility of the applicants.
5. The recipients must maintain a required scholastic level to continue receiving awards each semester.

There is no governing body for the Foundation. The trust agreement spells out exactly what is required of Regions Bank, the trustee for the Foundation. The following information is an explanation of that process:

1. All of the net income of the trust is distributed three times a year to the institutions of higher learning based on a ratio prescribed in the trust agreement.
2. Each institution administers the trust funds through its student financial aid office under policy set by the scholarship committee of each institution in making educational grants to student in conformity with the trust agreement.
3. Only students from Attala, Carroll, Choctaw, Montgomery & Webster Counties, Mississippi with a desire for higher education and potential ability to benefit from such education, are eligible for the awards.
4. Each of the institutions made residency determinations based upon Mississippi statutory law, judicial opinions and Attorney General rulings that address residence of each institution reviews the applications of students and uses various methods within the framework of the law to verify the residency and eligibility of the applicants.
5. The recipients must maintain a required scholastic level to continue receiving awards each semester.

Process to Review Form 990 - Once the Form 990 has been completed by the CPA, it is mailed to Monica Owen, who is a vice president and trust officer for Regions Bank. She reviews the tax return and then signs and mails the Form 990 to the Internal Revenue Service.
