Collaboration between Mason & Partners Clinic (MAP Clinic), Fairfax County Public School System & NSC to provide free immunizations to help meet the school-based entry requirements for children K 12th grade. Collaborate with both George Mason Universities Mason & Partners (MAP) clinic and Prince William Health Department to work with previously incarcerated individuals who are suffering from opioid addiction.
