The Basic Field Grant is the major entity's fund that provides legal assistance in non-criminal proceedings for qualifying financial disadvantaged program participants. Some of the proceedings covered are family law, domestic violence, employment, special education, health, housing law, juveniles, consumer rights, environmental law, migrant farm worker rights and community development. The basic program worked on approximately 18,000 cases for low income families during the year.

4b (Code:) (Expenses \$ 1,359,368 including grants of \$) (Revenue \$)

The Legal Services Corporation required that Puerto Rico Legal Services, Inc. (PRLSI) designate a minimum of 12.50% of its annual funding to private attorney involvement effort, encouraging attorneys in private practice to provide free legal assistance to indigent individuals and communities. The funding to private attorneys during the year provided services in approximately 6,500 cases for low income families.

Legal assistance is provided to migrant farm workers in the priority areas listed (4 a). During the year the organization provided services in 25 migrant worker cases and Disaster Relief Program to provide free legal assistance for qualifying families of low income suffering the impact of Hurricane Irma and Maria.
