FORM 990, PART III, LINE 1: The organization's mission is to stimulate equity and quality of life in Puerto Rico and the Caribbean by supporting local actions with an educational, social, cultural, environmental, and artistic focus. Envisioning a society where communities organize in different ways and implement resilient and socio-ecological strategies to improve equity and quality of life on the planet. Faced with precariousness and social inequality, more communities organize local actions addressing needs in health, economic development, social justice, culture, ecology, agriculture, and social welfare. Actions are carried out with few resources and limited access to funds, creating more barriers in communities already suffering from the effects of the crisis and historical inequalities.

FORM 990, PART III, LINE 4a: In 2019, HASER Projects focused on education and social actions that transform communities that have been historically marginalized by creating more equal opportunities for all. Our largest projects focused on equitable energy access for low income families with children, third generation members that required health equipment to live and were found without basic electricity two years after hurricane Maria. At the end of the year health projects in collaboration with social work school were developed to attend the growing aging population of marginalized communities in the east part of Puerto Rico and a food access program was started to address food deserts and connecting low income communities to agroecological food. Other HASER Projects focused on education of adults and youth in themes such as agroecology, sustainability, renewable energy, music and outdoor experiences.

All the people who worked in 2019 were under professional service contracts while the organization finished its employee handbook as well as its strategy. The prior years had been a process of recuperation for hurricane maria which made it difficult for the organization to build its interior infrastructure while supporting the recuperation of the island through specific projects. The independent contractor highest paid was the Executive Director at \$42,600/year.

All other contractors worked part time. The organization worked on its document so in the next year the organization can have employees as needed for management and projects.
