SAFCA HAS PAID AND IS EXPECTED TO CONTINUE TO PAY THE CONSERVANCY FOR PROVIDING THIS MITIGATION FUNCTION. HOWEVER, IT DOES SO IN A MANNER NEGOTIATED WITH THE FEDERAL AND STATE AGENCIES, WHICH IS SLIGHTLY DIFFERENT THAN THE BASIS FOR WHICH FUNDS ARE PAID TO THE CONSERVANCY FOR TRADITIONAL NBHCP MITIGATION.
