A grant provided to a foreign charitable organization, the Sai Maa Vishnu Shakti Trust, for the construction of the Sathya Sai Maa Moksha Dham Ashram in Kashi (Varanasi), India. The Ashram will be a sacred sanctuary that provides spiritual nourishments and humanitarian services. It will provide a sacred space for individuals to gather with a shared purpose of devoting themselves to their inner life and spiritual upliftment, will offer community life, education, common spiritual practices, that lead to individual and group transformation and spiritual evolution.
