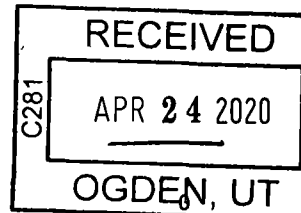

In-kind video and audio recoding and digital still picture were made by non-paid members of the organization, using equipment owned by the organization or volunteers doing the recordings. The recordings were done for and with the authorization of the Director of Bands or the director of the specific ensemble, and provided to the directors after the event.

The video recordings were loaded to U-Tube for use by the directors for evaluation and teaching. Students members of the groups are authorized to download the recording for their own archives. The recording are also used for public relations and recruitment of student.

Approximately twenty performances were recorded. The total value of the in-kind service is approximately \$20,000

Cash was used to purchase directly from suppliers Band Service Awards for students. The criteria for receiving an award was set by Band Directors based on years of satisfactory service to the Marching and Concerts Bands. The 2018-2019 award were presented in the springs of 2019 and we paid to the suppliers \$13,073.

In addition, a fund in the University of Arkansas Foundation has been set to endow the cost of the awards at a later date. We contributed \$8,000 to that fund during 2019.

The director of band serves on the executive committee of the organization and although he has not opted to make appointments, he is authorized to do so in our constitution. As practical matter, this origination undertakes only services as approved by the director of bands.
