The current University President & CFO and the past University President, who still resides on the Board, along with other board members make any inquiries until satisfied and provide feedback to the advisor. Foundation ranch land used by the University is discussed and the benefits received by University are presented by the Professors in the Biology Sciences department of the University and the participating students. Additionally, Foundation ranch land conservation, agricultural, wildlife or other activities are discussed. In regard to significant expenses such as financial support to the University, a methodology was established that is still used to day. The methodology was developed with direct guidance from the past University President who still resides on the board, to calculate the level of support provided by the Foundation to the University. At least annually, the current University President & CFO, the past University President and the remaining board of directors assesses the established support calculation methodology. The annual support amount calculated is presented to the board for consideration. After review by the University's past and current Presidents, its current CFO and other members of the board, if appropriate, the Foundation's board then votes to approve the support payment to the University.
