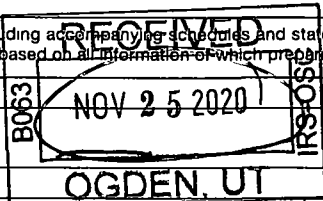

The Azaleas at Woldenberg Village is a sixty (60) unit assisted living community. Various levels of care are offered based upon an individual's specific needs. The Azaleas provides its residents three well-balanced meals per day, group activities, medical and recreational therapeutic transportation, 24-hour on-site caregiver support and weekly housekeeping. Additionally, the Azaleas houses a unit for early stages of dementia.
