Competitive Soccer Program - This is our program for the more skilled players who want to compete with other skilled players in the State. This program offers skills training with licensed, paid coaches (Contractors) who prepare players for a higher level of play. Games are scheduled through LSA and involve travelling around the State of Louisiana and sometimes to other neighboring states. This Program is open to ages 10 -18. It also includes a program for ages 8 and 9 to prepare a player for the competitive leagues.

4b (Code:) (Expenses \$ 43,812 including grants of \$) (Revenue \$ 76,116)

Recreational Soccer Program - This is our program for the player who wants to play soccer without the rigors of the Competitive Training. Coaches are volunteers. Games are scheduled on Saturdays during the season. Players can be ney level from beginner to highly skilled. The idea is for participants to learn the game and enjoy playing. This Program is open to ages 3 to 14. Age groups are U4 (little kickers - Age 3), U6 (Ages 4 & 5), U8 (Ages 6 & 7), U10 (Ages 8 & 9), U12 (Ages 10 & 11) and Senior Rec (Ages 12 to 14).

Recreational Soccer Camps - This program is for younger players to have more time to practice skills with a licensed coach. The camps are offered during the summer months and during holidays during the school year. The camps provide a fun way for players to improve their soccer skills.
