INTERNATIONALLY, CFH OFTEN PARTNERS WITH WELL VETTED MINISTRIES, SPONSORING COMMUNITY DEVELOPMENT PROJECTS LIKE DRILLING WATERWELLS, BUILDING SCHOOLS, CLINICS AND CHURCHES, AND PROVIDING SEED MONEY FOR MICRO-BUISNESS
