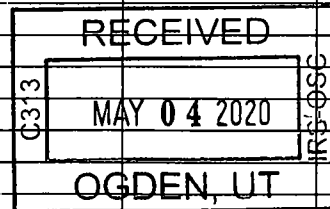

Part XV Purpose of Grants or Contribution

Artspace at Untitled provides a mentorship program for Oklahoma City Public Schools students to create, learn, and experiment with art. The program incorporates art history, theory and contemporary art trends into the curriculum.

Center for Children and Families provides a range of effective services to heal children who have been wounded by relationship trauma, strengthen families who are struggling with parenting challenges and empower youth to reach their full potential as caring adults.

Cleveland County CASA, Inc. is a court appointed non-profit advocacy group serving Cleveland, Garvin and McClain counties. CASA speaks up for children who have been abused or neglected and need a voice in the child welfare system. CASA's community volunteers are trained court advocates who give a voice to children who have no one to represent their best interests.

Eden Clinic (Formerly Care Net) provides pregnancy testing, counseling, education, and material assistance. Counseling includes education on the three options for an unexpected pregnancy. Education includes pregnancy and childbirth parenting. Ultrasound equipment is available for expecting mothers to get to know their baby prior to its birth. Material Assistance includes baby clothing, diapers, baby accessories and baby furniture. Referrals to other agencies are made as needed.

Deaconess Pregnancy and Adoption Services assists women in crisis pregnancies and provides adoption services.

Deliverance Ministries, Inc. is a non-profit, non-denominational, volunteer-reliant ministry providing group education and individual counseling and prayer with a focus on deliverance and inner healing. The program stresses that deliverance is not a one-time quick fix, but rather an important part of identifying issues and equipping people with methods and tools to gain freedom from harmful strongholds that are hindering their lives.

Food and Shelter (Norman, Oklahoma) provides hot daily meals for needy people and temporary shelter for homeless families in transition and counseling to encourage employment and resolving other problems of the homeless.

Hope House provides housing, support, and direction to disadvantaged women to help them gain education and employment and become contributing members of the community.

LoveWorks provides after school and summer programs for middle-school youth, where they are helped to discover their gifts, talents, strengths, and possible vocations through tutoring, life skills training, team work, community service, and leadership development.

Novo Ministries is an inner city ministry for children and youth offering after school, evening and summer initiatives.

Oklahoma Jail-Prison Fellowship is a non-profit, volunteer-reliant ministry ministering directly to jail and prison inmates through counseling and Bible study. Thousands of prisoners are touched every year by OJPF with nearly 2,000 professions of faith annually. OJPF is currently exploring a means of partnering with local churches to offer follow-up support for individuals once they are released.

Oklahoma State University (OSU) Foundation provides administrative services for scholarship funding for the Colleges of Education and Engineering for students with financial need.

St. Jude's Children's Research Hospital advances cures and means of prevention for pediatric catastrophic diseases through research and treatment. No child is denied treatment based on race, religion, or a family's ability to pay.

Salvation Army (Norman, Okla.) assists needy people with a variety of programs including food, clothing and temporary shelter.

Second Chance finds homes for abandoned and lost dogs and cats in Norman, Okla.

Wild Care Foundation provides medical care for injured wild animals and eventually frees them back into their natural habitat.
