4a (Code: ) (Expenses \$ 550,625 including grants of \$ ) (Revenue \$ 59,114 ) Educational presentations to school groups and the general public to inform them of the endangered status of sea turtles and how to support conservation efforts. In 2019 there were approximately 177,841 visitors to the facility. There were school trips both to the facility (196 trips, 8,953 visitors) and virtual field trips (96 with 6,233 participants), as well as outreach programs (22).

4b (Code: ) (Expenses \$ 800,922 including grants of \$ ) (Revenue \$ ) Rehabilitation of sick/injured sea turtles, care and placement of non-releasable sea turtles (non-releasable turtles are used for educational purposes.) Healthy sea turtles are released back into the wild. In 2019, 384 sea turtles were stranded, out of these, 346 were alive and 168 were dead. Of the 384 stranded, 24 were cold-stunned, 80 were revived and released.

4c (Code: ) (Expenses \$ 178,185 including grants of \$ ) (Revenue \$ 120,700 ) Sea Turtle, Inc supports conservation efforts world wide. On South Padre Island beginning in March, beach patrols are conducted both on foot and ATV's looking for sea turtle nests. The nests are recovered and moved to an enclosed coral for protection. When they hatch, the babies are taken to a safe place and released. Last year, there were 48 nests, 4,744 eggs with 3,694 hatchlings released. There were 7 public releases. In 2019 Sea Turtle had 8 interns during the nesting season and 2 in the fall/winter to help with operations.

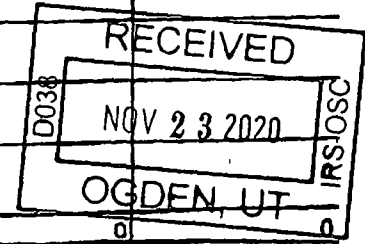
