COUNSELING AND OUTREACH PROGRAM (COP)2019 ACCOMPLISHMENTSIN 2019, AVDA'S LICENSED TRAUMA COUNSELOR PROVIDED TRAUMA-INFORMED THERAPEUTIC CARE, BOTH IN GROUP AND INDIVIDUAL SESSIONS, TO DOMESTIC ABUSE SURVIVORS AND THEIR CHILDREN. GROUP SESSIONS WERE HELD BOTH AT THE AVDA OFFICE AND IN THE COMMUNITY, HELPING SURVIVORS TO HEAL FROM THE DAMAGE CAUSED AT THE HANDS OF THEIR ABUSERS. AVDA'S COMMUNITY AWARENESS AND PREVENTION PROGRAM (CAPP) PROVIDES PREVENTION PROGRAMMING FOR ADULTS AND YOUTH TO HELP BREAK THE CYCLE OF ABUSE FOR THE NEXT GENERATION. CAPP GREW ITS OUTREACH TO YOUTH IN 2019 WITH 6,339 YOUTH PARTICIPATING IN ABUSE PREVENTION PROGRAMMING, INCLUDING SAFE DATES AND TEEN DATING ABUSE PREVENTION PRESENTATION. PART OF THIS GROWTH IS DUE TO THE EXPANSION OF ITS COACHING BOYS INTO MEN PROGRAM FROM FOUR SCHOOLS TO 18; THE ADDITION OF THE ATHLETES AS LEADERS PROGRAM (FOR FEMALE ATHLETES); AND THE ADAPTATION OF LIVERESPECT , WHICH TEACHES BOYS ABOUT HEALTHY MANHOOD, INTO AN EIGHT-WEEK CURRICULUM. MORE THAN 13,900 ADULTS WERE REACHED THROUGH COMMUNITY OUTREACH; CAPP INCREASED ITS IMPACT ON LAW ENFORCEMENT TRAINING, REFERRAL TRAINING TO OTHER DOMESTIC VIOLENCE SERVICE PROVIDERS, AND OUTREACH TO THE LGBTQ COMMUNITY. CAPP ALSO BEGAN DIRECT VICTIM SERVICES IN PASADENA AND LAUNCHED A MAJOR BILLBOARD CAMPAIGN TO REACH VICTIMS.
