Therapeutic Riding is an equine-assisted activity for the purpose of contributing positively to the cognitive, physical, emotional, and social well-being of individuals with special needs. Based on input from doctors, therapists, teachers and parents, the client's individual goals are designed to complement ongoing therapy and education. H.E.L.P. volunteers donated over 4,500 hours of service in 2019. This benefited 17 clients with 137 days of care and with 280 completed sessions.

Phoebe's Scholarship Fund provides financial assistance to existing and incoming clients that allows them to participate in this much-needed program. The Scholarship Fund helps riders who cannot otherwise afford this unique program, and in fact one client applied for and was approved for a 100% scholarship.

Equine Assisted Learning (EAL) is an educational approach to equine-assisted activities. The content is developed and organized by credentialed practitioners with the primary intent to facilitate personal growth and development of life skills through equine interactions. In an EAL setting, the experiential approach integrates equine-human interaction that is guided by a planned learning experience to meet the identified goals or desires of the participant. Working with equines provides opportunities to teach critical life skills such as trust, respect, honesty and communication. During 2019, this program benefitted two clients with 21 completed EAL sessions.
