All applications are reviewed by the BBMT Committee to decide if they will receive funds and determine the amount based on criteria which are determined in advance. Grantees are required to submit a followup report within four months. The report contains notes, photos and receipts for any garden purchases made with the grant funds. In addition they are asked to describe any challenges they faced and how those challenges were resolved. Many gardens receive visits from BBMT committee members, or local chapter members within a six month period to discuss their progress, challenges and provide further education to help maintain the garden. The award amount for the Ann Miller Gonzalez Research Grant for Graduate Students is sent to the awardee's Institution, which then disburses the funds to the student for items listed in the grant proposal. The awardee reports on their research at the annual Fall Symposium held by the Native Plant Society of Texas by public lecture to the society's members and attendees. The award amount of the Kate Hillhouse Scholarship is sent directly to the awardee's college and applied toward tuition costs. The awardee will also give a lecture regarding their research or program of study at the Native Plant Society of Texas annual Fall Symposium.
