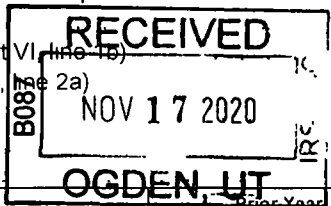

This return for a short period (4 months) is filed due to AIN's change in fiscal year from 8/31 to 12/31. Accordingly, the program service accomplishments shown here are for the most recently completed annual fiscal year. AIN provides 2,000 clients diagnosed with HIV/AIDS with care coordination through case management, while also providing outreach and HIV prevention services to 12,000 at-risk individuals. Transportation Program provides bus passes, van rides, or taxi rides for clients to reach and maintain medical treatment, stay in care, and access other support programs. Provided 9,000 van rides, 190,000 DART bus and train passes, and taxi rides. Daire Center is a wellness program provided in an adult day center setting consisting of nutrition services, non-medical support, stabilization, socialization, skills building activities, or respite care for high-need clients. Provided 90,000 hours of care
