THE COMMITTEE SHALL: RECOMMEND THE COMPENSATION OF THE ORGANIZATION'S EXECUTIVE (OR EXECUTIVE OFFICERS) TO THE BOARD; OVERSEE THE DEVELOPMENT AND ADMINISTRATION OF THE EXECUTIVE COMPENSATION AND BENEFITS PROGRAM; MAKE ANY RECOMMENDATIONS TO THE BOARD RELATING TO PROPOSED CHANGES IN THE COMMITTEE'S CHARTER.
