Project-based learning is the central method by which these two Youthbuild program components are integrated into the Fort Worth program.

TVC - The Veterans program offers financial assistance to low income veterans served during war time along with surviving spouses. This service was provided as a one time service that assists in quality of life and removing barrier to employment. The program provides ADA compliant modifications, weatherization and improving quality of life.
