EPACT provided approx 4,567 hours of supervision/supervised visits that resulted in families participating in quality family-time visitation that helped parents and children maintain their family connection and allowed displaced children a safe haven until new placements could be secured. 2. EPACT provided over 4,423 hours of transportation that aided parents and children in getting to and from court hearings in a timely manner doctors' appointments, new foster care placements and quality family time visits. 3. EPACT provided 54 mental health assessments and 152 hours of counseling that assisted clients in identifying and addressing individual and familial challenges and enhancing their self-efficacy skills and parental protective capabilities.
