A) Response to Part IX – A and Part XV – b

1. Board of Directors approved six separate gifts to major charitable 501 c (3) organization and did so with enthusiasm in 2019. Scholarship program at Aurora High School, the program is on hold to keep the The Lilli Foundation financially strong. Net assets decreased from \$ 3307 to \$ 3302 which represents a less than 1 % change. Program aimed at supporting efforts at other 501 c (3) organizations remains strong as we move into our 15 th year of operation.
2. Annual Board meeting was held on May 21, 2020 to review Foundation operation of FY 2019. All members with present on the teleconference or had proxy statements on 2019 operations. COI was reviewed by all members of the Board and Trustees of the Foundation and notation of this activity was included in the minutes of the meeting. Signed COI statements were filed in December of 2019.
3. A financial Spreadsheet of Foundation's transactions (2019) has been included. Barry W. Wessels and Aimee L. Latham conducted an audit of this spreadsheet. Board voted at the Annual Meeting to approve the audit and declare the operation and financial sustainability of the Foundation to be sound. Funding activity of outside awards, gifts to 501 (c) (3) organizations and/or scholarships is targeted at maintaining the total Foundation Assets at \$ 3300.
