Facts And Circumstances Test

Current Year Facts and Circumstances: The Cupertino Library Foundation (CLF) serves both as an advocate for the Cupertino Library and as an advocate for the Community. Serving the Library, we seek to promote the Librarys needs and preferences when it is difficult for the Library to do so (owing to policy and intergovernmental relationships). Serving the Community, we look to find gaps or needs in our Community and work with the Library, partners, and our own board members to experiment with and affect changes. All of our programs are free and open to the Community independent of residence in the City of Cupertino. The 2019 board is composed of nine unpaid volunteers and it is a working board. In 2019, we are extremely active in all areas. A major request from the Santa Clara County Library District was to promote the expansion of the Cupertino Library by the City of Cupertino (different agency than the County) to create large multi-functional meeting spaces. Cupertino being the lone major branch without such facilities. Such an expansion was on the de-activated project list as of the January City Council Meeting. CLF board members met with City Councilmembers, City Staff, and presented at open City Council meetings advocating for the Library Expansion. We engaged members of the Community to call on knowledge and skills to form opinions on what would be a good operational fit for our needs. We worked with the Library and the District on requirements, library operations, and funding for furnishings and AV. After dozens of presentations, and meetings, we were able to get a task force setup and partial funding commitment from the City. After many hundreds of hours, we were able to secure funding from the City and approval for the Library Expansion starting in 2020 and being completed by the end of 2021. Community volunteers also spent approximately 100 hours working with CLF in the project. CLF was able to resurrect a dead project and get it approved and on track for implementation. CLF provided the funding for the design, selection and purchase of new furniture for the Library Courtyard. This funding was a request from the Library to replace aged furniture and to provide a better user space for our patrons. The three phase project cost \$15,500 for the furniture and approximately \$2500 for the consultation. We also saw the transformation of an experimental Wellness Program started by CLF in 2018 into a official Cupertino Library Program. CLF provided funding for speaker compensation, room rental and video services (Approximately \$4000). There were six main topics comprising seven lecture events (one was both English and Chinese). In addition, the Library created a Wellness+ program as a follow-up for significantly engaged patrons. The lectures served approximately 450-500 patrons and the Wellness+ served an additional 200-300. CLF board members also provided operational support at these events. CLF and the Library partnered with the Cupertino Chamber of Commerce to do the 2019 Lets Talk Education Series aimed at helping students and parents understand the road to college and beyond. This included partnering the Fremont Union High School District, the Cupertino Union School District, other foundations and several local businesses. The CLF president was the chairman of the Committee and CLF board members managed three events and provided moderating for the panel discussions. There were seven events with approximately 700 participants in total. The Chamber of Commerce provided the funding for the space for the CLF events. The 2019 Super Summer Science Search (S4) program for Middle School students was run with the assistance of the Likachev Foundations grant. This program encourages small teams of students to do in depth research, data collection, problem definition, ideation, and presentations (written papers and videos) on the problem of What should our Library Program Room Expansion look like and do? This program involved 170 students, of which approximately half submitting final finished projects. We hired a project manager to oversee and train a Teen Advisory Council (TAC) to run the eight week event. The TAC included 12 high school volunteers who spent a year planning and executing this program representing well over 500 volunteer hours. CLF board members oversaw the operations and provided operational support by judging projects and officiating at the award ceremony. Cost \$10,500. CLF partnered with the Cupertino Senior Center to present the 2019 Classic Film Series. This series included three sub series on Science Fiction (6 films), Mystery (6 films), and Comedy (6 films). These were shown in the Cupertino Senior Center which donated space (estimated \$5400), setup (\$3600), and refreshments (\$1800). The Senior Center also waived the \$5 entry price for non-members which were 90% of of the attendees (est \$5500). CLF \$11,000 paid for the lecturer who hosted the movies and conducted the post movie discussions. Attendance ranged from 45-75 persons per film averaging 55. The demographic skewed heavily towards seniors and provided an opportunity for active socialization. CLF responded to other Library and Community requests for financial assistance including:-Funding for the Art Wall for the Library and the City Fine Arts Commission-Funding for the materials for the Cupertino Sister City Art program-Funding and operational assistance for TAC Fall Festival-Sponsorship for the Cupertino Rotary Golf Classic for raising funds for West Valley Community Services-Grant to the Cupertino Poet Laureate-Funding for the Cupertino High School Pioneer Hackathon IIMaterials for the public include-Videos and handout materials for the Wellness Series Events-Videos and materials from the S4 program events-Documents and meeting materials from the Library Expansion Task Force-Suggested reading materials to accompany the Classic Film Series
