**Original tax return was sent via mail and not received. The following updates our organization's questions regarding our public status.**

Since 2018 we have researched the possibility of asking to be considered a Foundation because over the past decade, the work of the organization has fallen upon one to three people while we maintain a large (10 member) Board.

**Redbird is 100% public supported, but our Board is not regularly engaged in our activities.**

In a Board of Directors meeting on December 5 we decided to change our By-Laws to have a three member Board. Until and unless there becomes a reason to seek Private Foundation status, effective December 7, 2020 Redbird will operate with a three member Board and an advisory council. This change has been recorded in our minutes and the By-Laws and Articles of Association are being updated at this time.
