Participants traveled to the city of Oaxaca, Mexico and the small village of Teotitlan del Valle home of FO TM documented artist Porfirio Gutierrez, for a unique exploration of the Zapotec culture, community and traditions during month of February and during annual dia de los Muertos, The Day of the Dead. Tour goers experienced the indigenous traditions including honoring ancestors, create cultural connections, and explore Oaxaca's artistic diversity. They experienced life today in Teotitlan del Valle and neighboring towns, they visited artist studios and historic sites, shared meals and participated in the festival preparations along with our host family. We explored Zapotec heritage and history, and consider how modern Zapotec identity is shaped by centuries-old customs.
