CONSERVATION:IN 2019, SFI CONTINUED ITS INVESTMENT IN RESEARCH THAT ADVANCES FORESTRY PRACTICES AND CONSERVATION SCIENCE. THE SFI STANDARDS REQUIRE PROGRAM PARTICIPANTS TO INVEST IN RESEARCH TO ADVANCE FORESTRY PRACTICES. IN 2019, \$57 MILLION WAS INVESTED IN RESEARCH BY SFI PROGRAM PARTICIPANTS IN MORE THAN 524 CONSERVATION-BASED PROJECTS WITH HUNDREDS OF PARTNER ORGANIZATIONS. THIS BRINGS THE TOTAL AMOUNT INVESTED IN RESEARCH BY SFI PROGRAM PARTICIPANTS TO \$1.8 BILLION SINCE 1995. SFI IS SUPPORTING RESEARCH TO MEASURE OUTCOMES RELATIVE TO WATER QUALITY, BIODIVERSITY AND SPECIES AT RISK, AND CLIMATE CHANGE RANGING FROM CARBON TO FOREST HEALTH. TWENTY THREE PROJECTS HAVE BEEN FUNDED, MEASURING EVERYTHING FROM WATER QUALITY TO CARIBOU HABITAT. SFI CONVENED A "SOUNDING BOARD" OF DIVERSE SCIENTISTS AND LEADERS FROM THE CONSERVATION COMMUNITY TO ENSURE OBJECTIVITY AND RELEVANCE OF CONSERVATION IMPACT RESULTS. TWO MEETINGS WERE HELD IN 2019 TO SHARE RESULTS AND IDEAS.COMMUNITY:SFI'S UNIQUE NETWORK OF 34 REGIONAL, STATE AND PROVINCIAL SFI IMPLEMENTATION COMMITTEES (SICS) REPRESENTS SFI ACROSS NORTH AMERICA. COMMITTEE PARTICIPANTS ENGAGED IN LOCAL COMMUNITY PROJECTS AND OUTREACH, MONITORING COMPLIANCE TO THE SFI STANDARD, AND PROVIDING LOGGER TRAINING AND LANDOWNER OUTREACH. IN 2019, SICS PROVIDED TRAINING TO ALMOST 11,000 RESOURCE AND LOGGING PROFESSIONALS, BRINGING THE TOTAL TRAINED SINCE 1995 TO ALMOST 214,000.SFI SUPPORTED 15 COMMUNITY GRANTS THAT FEATURED COLLABORATION BETWEEN SFI AND A DIVERSE RANGE OF PEOPLE FROM 78 ORGANIZATIONS TO SUPPORT COMMUNITY PROJECTS.SFI PROVIDES FACILITIES, MANAGEMENT AND ADMINISTRATIVE SERVICES TO PROJECT LEARNING TREE CANADA (PLTC), A NONPROFIT INCORPORATED IN CANADA. PLTC'S MISSION IS TO USE THE OUTDOORS TO ENGAGE YOUTH IN LEARNING ABOUT THE WORLD AROUND THEM IN RURAL, INDIGENOUS AND URBAN COMMUNITIESAND ADVANCE ENVIRONMENTAL LITERACY, STEWARDSHIP AND CAREER PATHWAYS USING TREES AND FORESTS AS WINDOWS ON THE WORLD. SFI IS THE SOLE MEMBER OF PLTC AND THE PLTC BOARD REPRESENTS A SUBSET OF THE SFI BOARD. IN 2019, PLTC WORKED WITH PARTNERS TO PLACE YOUTH IN OVER 1,300 GREEN JOBS ACROSS THE COUNTRY.
