And, working alongside our partners, we help to drive policy improvements that will improve young people's lives. These strategies unite everything we do. In 2018, we helped to expand young people's access to quality out-of-school time programs, dual credit, and restorative justice alternatives to suspension. In 2019, we expanded these strategies and also significantly strengthened our youth voice and leadership work.</u>

P16 Plus of Greater Bexar County dba UP Partnership provides services to community partners through a delegate agency contract with the City of San Antonio. In 2019, the focus of that work was to ensure that youth development providers funded by the City of San Antonio utilized common youth data and benchmarks to understand and adequately respond to the needs of young people across our city. Two strategies were utilized to accomplish that work: (1) A data access strategy for equipping the leaders who operate these agencies with reliable data on their participants' outcomes and their school and community environment thereby increasing their ability to make data informed decisions and customize program improvements; (2) a data capability strategy to help organizations clearly understand how to put their data to use for program improvement. We achieved these goals and successfully built agency level dashboards for youth-serving institutions and helped agencies put their individual outcomes and program data in context of the larger youth-serving ecosystem.</u>

In 2019, Diplomas partners were convened monthly to develop action plans based on student outcome data.</u>
