Washington Communities for ChildrenWashington Communities for Children (WCFC) is a network of regional coalitions with a mission to connect local and statewide efforts to improve the well-being of children, families, and communities. There are ten WCFC Regions across Washington State that together have trusted relationships with over six hundred organizations and individuals. Partners include early learning providers, social service agencies, early intervention services, child welfare organizations, libraries, juvenile courts, school districts, public health agencies, higher education, families, and many others. A fundamental belief of WCFC is that the numerous and complex systems supporting children and families in Washington State must be coordinated in order for children to achieve success in school and life. WCFC brings together critical community resources, regional expertise, and robust cross-sector relationships in order to improve systems and achieve measurable results. This structure ensures communities have the ability to respond to the changing state landscape, influence decisions, elevate community voices, and coordinate representation at state-level tables.

## **Form 990, Part III, Line 4b:**

Help Me Grow Pierce County Help Me Grow (HMG) is a national model designed to connect families to community resources to support healthy child development. In Pierce County, community partners conducted a year long planning process to strengthen and expand the system of supports for children pregnancy through age 5. More than 120 community organizations, government agencies, funders and parents are now working together to implement HMG. The program has the following components:

- Centralized Access Point** - Parents, caregivers, early learning, health and other service providers can call, text, or email HMG and connect to caring people who are highly trained in child development. The resource navigators listen to families needs and link them to the most appropriate services.
- Family and Community Outreach** - This team promotes child development information and the use of the HMG system that is accessible and convenient for families. They provide opportunities for networking among service providers, improving coordination among various agencies for a seamless system of parent support.
- Data** - This team reviews population based data on Pierce County children from prenatal to age five, to determine the greatest areas of need and plan for ongoing analysis and improvement of the HMG system. Data collected through the Centralized Access Point ensures a systemic view of family needs throughout our community, and guides advocacy efforts for additional investments in children and family services.
- Health Provider Outreach** - the HMG system supports pediatricians and other health providers, by offering one referral source to address a child's social, behavioral, developmental, and emotional needs. The Centralized Access Point partners with health providers to ensure effective linkage to the additional services a family may need, and provides follow up to providers on the status of their referral.

Help Me Grow Pierce County envisions a vibrant community where all families have the resources and confidence to support, protect, nurture, and dream for their children.

Project Child SuccessProject Child Success (PCS) is a collaborative movement to improve the wellbeing of children, families, and communities in Pierce County. Over 170 organizations and individuals have come together to achieve the vision that all children thrive in nurturing relationships and environments. To do this, PCS partners focus on building the following five protective factors: Concrete Supports - Basic needs like food and shelter; Knowledge of Child Development - an understanding of how children learn and grow; Social Connections - someone to turn to for support; Resilience - the ability to bounce back when things are tough; Social Emotional Competence of Children - A way to understand and manage feelings. PCS is led and governed by a Steering Committee, made up of community partners. The Steering Committee guides PCS direction and provides strategy and oversight to the initiative. In addition, there is a monthly partnership meeting and two Action Teams that also meet monthly to carry out the following activities: Connect - gather regularly to share, learn, discuss, and dream; Learn - educate the community through trainings and skill building; Research & Data - collect and analyze data to learn about children and families and design solutions; Innovation & Action - Work collectively on projects that directly impact children and families; Advocacy & Policy - Champion systems and policies that support children and families.
