We conducted a 1 day meeting in February in preparation for the student field trip to Orlando. We executed three days of training in Orlando, including leadership, relationship building, communication skills, and afternoon fun in the parks. We conducted a graduation ceremony for the students. We engaged 30 parents in 10 evening workshops and covered the following topics: civic engagement and education, the law of attraction, mindfulness and meditation, and the automatic millionaire.

Part III Line 1 Our mission is to be a change agent in the transformation of poor and low income communities from a perceived places of poverty, low skills, and despair to places of prosperity, abundant skills, and hope. The Dollars For Your Thoughts program engaged 101 Sunflower County middle and high school students in a 4 weekly training sessions for 5 hours per week and in dialogue and conversations about their present circumstances and their outlook for the future. These dialogues included discussion about health, nutrition, education, race, social interactions, and healthy relationships. The conversations entailed demonstrating how our thoughts and feelings about our circumstances and how our outlook on life determines what our future will look like. The training sessions also help students to align their unique strengths, talents, and gifts, and greatest passions with a clear vision for the future. The intention of this project is to inspire youth to take purposeful action in the present so that they can create a life of great fulfillment for the future. One of our goals is for the students completing the program to have a positive impact on their peers and on the Mississippi Delta. We also engaged 34 adult students and parents in a 10 weekly program to teach them some of the same topics that we teach the students. We also teach them mindfulness meditation, parenting skills, and steps to achieve success for both themselves and their children. This year we provided nutritious food from the food pantry to approximately 400 families per month. We provided field trips to expose the students to life outside the Mississippi Delta. We recruited 200 volunteers to build a playground in the City of Drew, Mississippi.
