Health, Education, and Advocacy. Besides continuing to provide health, education, and advocacy for over 200 East African women children to gain access to healthcare, education, and our advocacy, this year we continued to focus on youth of families education and physical well-being. We offered three core programs: tutoring, girls scouts, and youth scholars. One, our tutorial program focus on homework assistance for K-12 was held weekly. In a culturally appropriate environment, volunteer tutors from Point Loma Nazarine tutored 40 East African youth enabling them to gained a better understanding of the subject matter, and to interacts with their peers. Two, the East African Girls Scout program continues to thrived. Fifteen girls learned to wok together and engaged in activities such as learning how to cook healthy food, money management, marketing and the selling cookies. Furthermore, the girls learned the importance of taking responsibilities and completing their task in appropriate time frame. Thirld, we established a Youth Scholars program for East African boys from 5-17. The boys are divided into age appropriate groups and discussed topics such as bullying, financial literacy, and to discuss their experiences in schools and other public venues. Equally important, we continued our "Women Only" swim classes and girls basketball program at the Prlice- Copley YMCA.

TAY. We continued to provide an artistic expressional environment that includes the use of multiple models of artistic express- al includes but us not limited to visual arts, spoken word, musalic, videos, performances and social media created and developed by Transitional Age Youth(TAY), 15-25 years old, and who are cientes of mental health system, Severe Emotional Disturbance/ Serious Mental illness, or at risk mental health challenges to improve their engagement and access to services while reducing the stigma. Again, under this year we accomplished reducing the stigma by engaging TAY 's activities such as open mic.

Female Genital Cutting Prevention. Under the auspices of Department of Health and Human Service Agency(Office of Assistant Secretary of Health Prevention Project) UWEAST continues to provide the following services to East African women whom are affected:
1. Staff Training and Preparation. We continued to trained and update staff of UWEAST on how to conduct the focus groups, Interviews, as well as surveys by taking the Dunya Facilitator Training.
2. Recruitment. Our recruitment strategy of going to places where community member frequent on a regular basis has been fruitful. Our outreach efforts focus on mosques, churches, adult schools, and farmer's market. 50 people are recruited on average.
3. Education: We continue to promote Dialogue with Doctors, special clinic, and other community events.

Additionally, this negative personal interactions echoes in the news and old social media led them to questioned their sense of self-worth and belonging: "Am I American? And I Muslims? and "Who am I?. To address this issue, we continued to provide East African girls' positive development and self-image, with the following core activities: 1) Safe Space, 2) Inter-active self-empowerment workshops, 3) Cross-cultural activities, and 4) Leadership skills and civic engagements.
