SPECIAL MEMBERS WHO ARE UP FOR ELECTION WILL BE EXCUSED FROM ATTENDIN G THIS EXECUTIVE SESSION IN ORDER TO ALLOW FOR DISCUSSION AND VOTE. ANY MEMBER OF THE CORP ORATION MAY BE REMOVED FOR CAUSE BY A 2/3 VOTE OR GREATER OF ALL DIRECTORS CURRENTLY SERVI NG. SUCH REMOVAL SHALL BE WITHOUT PREJUDICE TO THE CONTRACT RIGHTS, IF ANY, OF THE PERSON SO REMOVED. WRITTEN NOTIFICATION OF INTENT TO REMOVE ANY MEMBER SHALL BE CIRCULATED TO ALL VOTING DIRECTORS AT LEAST 15 DAYS PRIOR TO ACTION TO REMOVE.
