In 2019, GCN provided informal education to 97,000 children at risk in refugee camps in Myanmar and Bangladesh; provided 30,000 farmers with Agricultural Training in eastern Myanmar; provided vocational training to 2,237 people in Burma and Thailand; provided shelter for 320 households in Rakhine State Burma; and provided 14 tube wells for 14 villages across Burma.
